Federal Community Housing Initiative

Rental Assistance Program

April 2018 – March 2028

Community Housing Providers/Co-op under Federal Operating Agreements

Community Housing Transformation Centre

Technical assistance, tools and financial resources

Launching December 2019

New and existing Community Housing Providers

Sector Transformation Fund

Financing assistance to support more effective business models and increased capacity

Launching December 2019

Contributions up to \$50,000 per project

Community Based Tenant Initiative

Funding to support tenants' access to information on housing options

Launching December 2019

Up to \$25,000 per project



Funding Options

Preservation Funding

- Support for long-term planning activities
- Existing Community Housing Providers
 - Currently under Federally Administered Agreement
 - Expired Agreements transferred via SHA
- Up to \$50,000 in contributions

SEED Funding

- Pre-development activities
- Minimum of 5 (new) affordable units
- Community Housing, Government, Private Developers
- Up to \$150,000 in contributions
- Up to \$350,000 in no-interest loans



Funding Options

National Housing Co-Investment Fund

Low-interest repayable loans and/or capital contributions

New & Repair options

Minimum 5 units

Up to 40 year amortization

Projects to meet key priorities of NHS



Funding Options

Mortgage Loan Insurance with flexibilities for Affordable Housing

CMHC Insured Loans for Rental Housing

New & Refinance options


Minimum of 5 units
