GOVERNMENT RELATIONS

MNPHA meets with Minister Squires

Last Wednesday, representatives from MNPHA's staff and board had the opportunity to meet with the new Minister of Families, Rochelle Squires.

MNPHA reiterated its commitment to supporting the non-profit sector in the community delivery of social housing in partnership with Manitoba Housing. We discussed our Sector Transformation Strategy

to help the non-profit sector take on responsibility for more units, and stressed the importance of working with community to provide wraparound supports for those who need additional supports, including those exiting homelessness or at risk of becoming homeless.

The Minister confirmed that she is looking forward to deepening the partnership with MNPHA and continuing to collaborate with the non-profit housing sector.

MNPHA EVENTS AND UPDATES

Centralized Waiting List

MNPHA has been proactively reaching out to the community to find out what kind of resources our non-profit sector needs to build the capacity to assume responsibility for more of Manitoba Housing's direct managed units.

One of the things that we heard loud and clear from community organizations is their fear that navigating affordable housing will become increasingly difficult once Manitoba Housing exits as a direct housing provider. There are currently about 300 different organizations that offer subsidized housing across the province, each with their own application process and waiting

list.

At MNPHA, we have been researching the feasibility of providing a centralized waiting list that would simplify the process for both housing providers and applicants. We have reached out to many housing providers and community organizations to hear their thoughts on what that could look like. Now we'd like to speak to people who are:

- 1. Currently on a waiting list for subsidized housing through either Manitoba Housing or another organization that provides subsidy; and
- 2. Tenants who have recently been housed in subsidized housing.

FUNDING OPPORTUNITIES

Applications for Co-operative Housing Federation of Canada 2021 Greener Co-op Microgrants are now open.

Housing co-ops are encouraged to design and implement projects that will help green their communities. Even the grant money is green! It comes from a fund to offset greenhouse gases emitted when staff travel across the country by plane, train or car.

CHF Canada will fund small projects from \$500 to a limit of \$8,000 to help improve your coop's environmental sustainability. All CHF Canada member housing co-ops can apply. Apply by March 28. For more information and to apply go <u>here.</u>

CFP: Feminist Response and Recovery Fund

Women and Gender Equality (WAGE) is investing \$100 million to support women, and in particular underrepresented women who have been disproportionately impacted by the pandemic, for an inclusive recovery.

Funding will support systemic change projects working to tackle barriers or implement solutions in policies and practices, resource distribution, networks and collaborations, systems of power and authority, and/or gender norms and attitudes.

Canadian Alliance to End Homelessness has launched a podcast called On the Way Home!

This brand new podcast aims to bring together the voices and issues involved in ending homelessness in Canada.

The first podcast, which aired on February 25th, features Michael Braithwaite, co-host and Blue Door CEO, and Stefania Seccia, co-host and CAEH Communications Advisor, interviewing Edmonton Mayor Don Iveson about his commitment to ending homelessness.

Canadian Mortgage and Housing Corporation Study, "Is Rental Housing Affordable to Low-Income Households" now available to the public

This research analyzes trends in housing affordability directly from the supply side of the rental housing market. One-fourth of Canadian households live in housing that is unaffordable and the situation is worse for renter households.

Key highlights from this paper are that:

- Low-income households, particularly those requiring one bedroom, are the most impacted by the chronic lack of supply of affordable rental housing in the country.
- In Winnipeg, there are very few units (from 2011, less than 6% of rental units) affordable to the lowest income households requiring one bedroom
- Analysis shows a negative correlation between the changes in the percentage of onebedroom units that are affordable to the poorest Canadians and the incidence of core housing need.

CHRA Indigenous Caucus Shares New Statement on Reconciliation and Cultural Principles

Over the past several months, the CHRA Indigenous Caucus and Board of Directors have worked with Namerind Housing in Regina to develop a new "Statement on Reconciliation and Cultural Principles" – the Statement was endorsed by the CHRA Board of Directors in January 2021. Adopting this Statement demonstrates CHRA's clear commitment to reconciliation with Indigenous peoples in Canada, and will form an important framework for how we work moving forward. We encourage all members and organizations to review this document and consider adopting similar statements in your own



organizations.


