We are currently hiring a **Case Management Support Worker** that will provide intake, assessment and resource connection support to people accessing the Rent Relief Fund.

## Non-Profit Housing in Parkland Region

The MNPHA team visited non-profit housing providers in Manitoba's Parkland region in July. Non-profits in the region include:

- Elbert Chartrand Friendship Centre Housing, recently took on management of all of the Manitoba Housing in the Swan Valley region. They tripled in size and have been able to provide more community-based responses and services to tenants.
- Sagemace Housing Inc. has sponsor management agreements for housing in Camperville, MB. The municipality is very involved and supportive of ensuring housing is supporting residents and the economic/social
- goals of the community. Mayor Sonny Klyne is Board President (and on MNPHA's Board of Directors)
  Canadian Mental Health Association Parkland Region has Echo Housing transitional housing for people experiencing and at risk of homelessness, as well as family housing. The CMHA provides some of the only housing for single individuals in a community struggling with a homelessness crisis.
- Parkland Mental Health Housing is a small but mighty organization, with board members from its sister organizations (CMHA and Elbert Chartrand Friendship Centre Housing) in Swan Valley because the community knows how essential non-profit housing is for people experiencing mental health challenges and are keen to be involved and support it.

Folks from the region talked about the importance of networking and recieving support and connection with their fellow housing providers in Manitoba. MNPHA staff are looking forward to meeting with more of our members as it becomes safer to see people in person and learn more about your successes and challenges.

# Jubilee Fund Celebrates First Rent Guarantee and Funding for Rainbow Resource Centre

Jubilee Fund has secured an apartment for a

single mother of two young children in the first successful rent guarantee as part of the Rent Guarantee Program! The family moved into their new home on July 7th, and are receiving continued emotional support from Jubilee Fund as they adjust to their new situation. The family is in need of a few items including a bed, as the mother is sleeping on the floor. Find a list of needed items and read more about this story by <u>clicking here.</u>

Jubilee Fund is also celebrating the completion of an agreement between Jubilee Fund, Assiniboine Credit

Union and Rainbow Resource Centre that provides a \$125,000.00 loan guarantee develop much needed affordable housing. With a loan guarantee made possible by Jubilee Fund investors, Manitoba's Rainbow Resource Centre, Canada's longest running 2SLGBTQ+ resource centre, has become the latest organization to receive support from Jubilee Fund.

Part of a larger \$1.1 million financing package arranged through Assiniboine Credit Union, the funds will be used to purchase a historic property in Winnipeg's West Broadway neighborhood which will see the building on site repurposed to a new headquarters for Rainbow Resource Centre as well as development of a 29 unit affordable seniors housing for the 2SLGBTQ+ community. # *Call for Letters of Intent for Capital Projects to Create Transitional or Supportive Housing in Winnipeg*

End Homelessness Winnipeg as Community Entity for Reaching Home is now accepting Letters of Intent for capital projects that will increase the supply of transitional and supportive housing units available in Winnipeg by March 31, 2024.


Eligible projects include new construction, and conversions (renovations) from non-residential use to transitional or supportive housing units. Funding is not intended to renovate existing housing, but rather, to create new units. If your organization has capacity and your Capital project is underway or is nearing completion and in need of additional funds to complete, please submit an expression of interest letter requesting to be considered.
