Five Things to Know about Manitoba's Seniors Strategy

The newly created Department of Seniors and Long-Term Care developed a <u>Strategy to make Manitoba a Great Place to Age</u> Their process of co-development involved collaboration with a diversity of stakeholders including seniors, families, caregivers, front-line service providers, senior serving organizations, clinical services, and various government departments. The Department has committed to ongoing collaboration and partnership in the implementation of the strategy, which will include a partnership and advisory structure that supports integration and communication, as well as a performance framework.

MNPHA was pleased to participate in this co-design, which to date has been an integrated, engaging, and effective strategy development initiative. Here are five things for the Community Housing sector to know about the strategy:

- 1. The goal of the strategy is for Manitobans to live vibrant and independent lives that allow each to age in our home or communities for as long as we wish and for as long as it is safe to do so. The vision for Manitoba's seniors strategy is older Manitobans are valued and empowered to live healthy and productive lives in our communities, making Manitoba an ideal place to age.
- 2. Strengthening home care, in every setting, is foundational.
- 3. The concept of a village shapes the vision for communities in the future. These villages can be physical or virtual, and include a range of supports and services that can support Manitobans as we age on a continuum.
- 4. There are not clear or commonly understood definitions of the various types of housing seniors are accessing. The strategy aims to explore how capacity can be increased and how to define the role and types of housing settings with services (including independent living, assisted living, and supportive housing), leveraging village and multi-generational housing models that include co-locating other services and supports, while taking into consideration affordability and safety.
- 5. In addition to defining the roles and types of housing, the strategy will also involve developing quality standards, guidelines, and governance for seniors services delivered by public, not-for-profit and private providers, with an initial focus on seniors housing, home care and personal care homes.

Ten Things to Know about Manitoba's Homelessness Strategy

Manitoba has released its <u>homelessness strategy</u>, announced in the 2022 throne speech and developed over the year through consultation internal and external to government.

The homelessness strategy includes initaitives that will impact a variety of sectors and stakeholders. This analysis focuses on the intiatives related to the Community Housing sector. A number of initiatives respond to MNPHA's longstanding policy objectives: new supply of community housing, capital funding for community housing, and supports within community housing.

- New social housing units will be created. This will begin with 700 in 2023/24, a welcome contribution after many years with limited new supply.
- 2. The planning and development of these units will be led by Manitoba Housing. This is also a welcome shift, as the non-profit and cooperative housing sector has had to piece together funding from various levels of government and charitable donations to develop housing since the release of the National Housing Strategy, without a clear and ongoing source of funds at the provincial level.
- These 700 new units will be created through a combination of construction, acquisition, and rent supplement agreements, with 400 of them being rent supplement. While substantially more than
 - 300 new units are needed to meet demand, there are benefits to the immediacy of rent supplements and it means that some non-profits that have units available at market rents could potentially access the supplement to be able to offer rent-geared-to-income units to individuals experiencing homelessness.

- 4. The government is increasing the maintenance budget for social housing to deal with vacancies that occur due to units requiring repair. The extent of this increase is unknown until the budget comes out, March 7.
- 5. Support for tenants, through a variety of methods and a continuum of need, is included. These support services include staffing in new supported housing facilities, and three levels of service for tenants: low levels of need for those who only require minor housing assistance; medium intensity to facilitate access to provincial health and social services; and high intensity for clinical supports and assistance with daily living.
- 6. Capital funding and operational funding for transitional housing projects are included in the strategy, expanding the diversity and availability of transitional housing for those who need it. Only projects in Winnipeg are identified at this time.
- An EIA-equivalent assistance fund is being developed for those who are waiting for intake and assistance to EIA. This will support rapid access to housing for those who do not yet have income supports.
- 8. <u>The Rent Relief Fund</u>, which MNPHA has developed over the past two years, will continue and will be evaluated for one more year. As of December 31, 2022, the Fund has supported over 875 households to prevent eviction, including many in community housing who would likely experinece homelessness if they were evicted from the rent-geared-to-income home.
- 9. Manitoba Housing is doubling the Bed Bug Grant program, which funds community agencies to support clients in dealing with pests.
- 10. The Housing Supports Initiative is being extended, with funding from 2023-25. This funding has supported 19 different projects across Manitoba to support tenants in accessing case management, housing supports, eviction prevention, and to build the capacity of the non-profit sector to provide housing to those experiencing and at risk of homelessness.



1.2M renters yet to apply for Canada Housing Benefit, and time's running out

Low-income renters in Canada have less than six weeks left to apply for the one-time \$500 <u>Canada</u> <u>Housing Benefit</u>. The government of Canada encourages <u>eligible renters</u> who have yet to apply for this non-taxable and non-reportable benefit, to submit their application ahead of March 31.



The federal government launched the benefit on Dec. 12 to assist lower-income individuals and families "who struggle with the cost of rent." So far, more than 500,000 Canadians have applied and 1.2 millionrenters have yet to apply to receive the benefit.

Please Note: while EIA does not consider this income and will not reduce benefits due to receiving it, renters who have EIA pay their rent directly do not qualify.




Housing Supports Initiative Profile: Sara Riel helps Tenants at the McLaren Hotel

Last month Tara Snider, Executive Director of Sara Riel, invited MNPHA's Cheryl Krostewitz and Jo Dworschak for a meeting and tour of the McLaren Hotel. This historic hotel has 150 single room occupancy units. With program funding from the Housing Supports Initiative, Sara Riel has a case manager and community mental health worker supporting 130 people on-site each day.

At this time, tenants have limited access to running water, no kitchen in the building, and microwaves and toasters causing breakers to overload.

While many had assumed the tenants were previously homeless a tenant survey confirmed 70% of tenants were living in better accommodations, but moving to McLaren prevented them from experiencing homelessness. There are renovation plans for each unit to have its own bathroom, and two large communal kitchens would be added to the building, both the ideas from the current tenants. It was wonderful to see the passion and commitment of all those involved in making a positive impact on the lives of those who call the hotel their home.
