#### Tenant Drop-in for Accessing Tax Documents

The third Thursday of each month (January 16, February 20, March 2) between 10:00am - 2:30pm MNPHA Office, 102-90 Garry Street, Winnipeg

**Canada Revenue Agency** representatives are available to meet with tenants of non-profit housing providers at our office on the third Thursday of each month from 10:00am - 2:30pm.

They're providing assistance with accessing online MyCRA accounts and copies of Proof of Income statements, which are required for subsidized housing applications, Rent Assist applications, and copies of Child Caregiving Benefits (CCB) statements. The representatives are knowledgeable and can provide updates and information on the status of individual's CRA accounts.

**Tenants must** have or know their SIN number. Valid government issued ID to access this service (passport, drivers' license or health card are acceptable) is preferred, but support can be provided without it.

As a part of the government's public engagement efforts for Budget 2025, the government is connecting with Manitobans through telephone town halls, in-person meetings and survey questions. Information about in-person and telephone townhalls will be available soon. MNPHA will share our budget priorities and recommendations in the new year.

MNPHA will continue to share the need for government to:

- 1. Create a capital repair and modernization program to significantly reduce the existing capital deficit within non-profit housing to meet the needs of the next generation of Manitobans
- 2. Provide consistent, long-term funding for supports within community housing
- 3. Create an additional 10,000 units of community housing
- Work with the non-profit sector as the preferred partner in delivering Manitoba's social and affordable housing through adequate operating funding, co-development of programs, and sector support

#### MNPHA Non-Profit Housing Survey

#### **Understanding Hoarding: For Landlords**

In this session, Lindsay Bacala will examine the basics of hoarding disorder, placing particular emphasis on the primary risk factors that can trigger or worsen the condition. She will then outline foundational treatment approaches informed by attachment theory and cognitive-behavioral perspectives, demonstrating how these frameworks can guide intervention strategies.

She will also illustrate how a harm-reduction perspective can be effectively employed in the context of hoarding disorder, underscoring practical, incremental methods for symptom management.

# Housing Starts Here: Capital and Operating Funding to Expand Social Housing

Manitoba Housing has introduced Housing Starts Here, to expand housing supply and end chronic homelessness in Manitoba.

Manitoba Housing will prioritize funding projects that create:

- Social housing, with <u>rent-geared-to-income</u> set at 30% of tenants' household income(<u>see program income limits</u>), accompanied by support services
- Affordable housing, with rents and tenant incomes at or below the <u>Affordable Housing Rental Program</u> limits
- Market housing see the <u>Rental Housing Construction Incentive</u>

Through the new streamlined intake, organizations with housing proposals can submit one application to apply for multiple programs any time while funding remains available, including:

- Proposal Development Funding
- · Capital Funding Program
- Rental Housing Construction Incentive
- Support Services Funding for New Supply
- · Operating Funding for New Supply




# Call for Letters of Interest for Supportive and Transitional Housing in Winnipeg

Funding of up to \$3,000,000 per project is available to support the creation or redevelopment of housing that addresses transitional and supportive needs for individuals experiencing or at risk of homelessness.

#### **Key Priorities:**

- Projects for youth or chronically homeless individuals.
- Initiatives led by Indigenous organizations.
- Projects must ensure funds are fully expended by December 2025.



#### Subsidy Program Applications are Now Open!

Volunteer Manitoba is excited to launch their second round of the Professional Development Subsidy! The program is designed to eliminate financial barriers to organizations looking to access professional development.

#### Who is Eligible?

- Non-profits and charitable organizations
- Organizations operating in Manitoba with an annual budget under \$1,000,000

#### **Subsidy Amount & Coverage**

The subsidy covers up to 75% of workshop fees. Once approved, applicants are responsible for paying the remaining balance 10 days before the workshop. One application per intake period per organization Intake deadline is January 15, 2025 - <u>Learn more</u>

#### Financial Wellness Coach - MNPHA Rent Relief Fund

The Rent Relief Financial Wellness Coach will provide financial counselling and support to participants that require additional assistance to access benefits, file their taxes, and manage their budget as identified by a team of Housing Stability Coordinators. The successful candidate will work to address a variety of money management related challenges that affect Rent Relief Fund (RRF) participants. This includes but is not limited to debt management (including advising or referring to external agencies for consumer debt proposals/bankruptcies), day-to day spending habits, and access to financial documents that are preventing the acquisition of benefits.

The Rent Relief Financial Wellness Coach will have excellent and assertive written and verbal communications with a wide range of audiences, be resourceful and detail-oriented, and able to work well both independently and within a small team. Learn more

#### Energy Efficiency Advocate - MNPHA

The Energy Efficiency Advocate will be working with non-profit housing organizations and Efficiency Manitoba (EM) to promote energy efficiency programs and awareness, and create and implement a non-profit housing energy efficiency plan.

The position will also help identify energy-saving opportunities in non-profit housing and encourage participation in Efficiency Manitoba's energy efficiency programs, ultimately leading to reduced energy consumption and lower energy bills.
